



I am looking for a sponsor so that I can go to school!

My name is N.N.. I am 6 years old and live with my parents and x siblings in Kikondo District Kyotera/Uganda. I go to St. Jude Nursery & Primary Day & Boarding School in Kikondo in the first class of primary school (Primary 1). My parents don't have enough money to pay school fees for me. But I really want to continue going to school because otherwise I don't know how I will manage my life.

Kikondo is a small village in a rural region in southern Uganda, about 45 kilometres south of the city of Masaka. The population living there is poor. Most families do not have sufficient income to pay their children's school fees.

In 2019, Jude Kayiwa, himself director of a large school in Masaka by profession, founded a school in Kikondo with his own funds and the support of friends. More than 400 children aged 3 to 12 now attend the school.

Since 2022, we have been supporting the school on the basis of a concept with the aim of developing the school to a high standard in the long term with a model character.

One important step of this development process is securing funding for the school's ongoing operating costs through school fees. As only a few families of the school children can afford the required school fees, school fee sponsorships are needed.



The sponsorship model:

- A monthly cost contribution of € 40 is necessary for one school child.
- Each sponsor can contribute a share of € 20 or € 40 to this cost contribution for a number of months to be determined by the sponsor. The cost contribution can be paid monthly, quarterly, semi-annually or annually in advance by bank transfer to the Foundation's bank account with the IBAN DE17 6035 0130 0001 1098 14. At the sponsor's request, it is also possible to set up a direct debit by SEPA direct debit, which can be terminated at any time.
- The foundation guarantees that the sponsorship money will be used exclusively as school fees for the school attendance of the respective sponsored child. For this purpose, the Foundation keeps personal accounts for the respective sponsored children, and the sponsor can request information about the status of the relevant account at any time.
- Before taking over the sponsorship, each sponsor receives initial information about the respective sponsored child with a photo, personal details and a brief description of his or her current situation. At the end of each school term (every six months), the sponsor receives a report on the educational development of the sponsored child.
- If a sponsored child leaves the school, the sponsorship ends without the need for further declaration. The sponsor will be informed immediately. Any unused sponsorship money paid by the sponsor will be refunded or used for another sponsored child of the sponsor's choice.
